### Application Checklist for Amending Plat

- \_\_\_\_\_ A note identifying what element(s) of the plat is (are) being amended and the words "Amending Plat" shown in the title block.
- \_\_\_\_\_ The exact name of the previous plat, which shall be retained in the title of the Amending Plat, identified.
- \_\_\_\_\_ Amending Plat signed and sealed by a surveyor.
- \_\_\_\_\_ Copy of existing plat.
- \_\_\_\_\_ The acreage of any lot or parcel involved in the application, identification of any drainage structure, and the location of all easements and set backs.
- \_\_\_\_\_ Certification from the appropriate representative of the subdivision where the property is located stating that the Amending Plat complies with existing deed restrictions and covenants.
- \_\_\_\_\_ Certification from the \_\_\_\_\_ County Department of Natural Resources approving any on-site sewage facility or other matter within its jurisdiction.
