**CITATION #:**

You, the Defendant, have the right to enter a plea of guilty, not guilty, or nolo contendere (no contest). You have the right to remain silent. You have the right to retain an attorney to represent you. You have the right to a jury trial. You have the right to confront and cross-examine the witnesses against you. You have the right to pre-trial "discovery" of evidence, including any evidence that is favorable to you and might even prove your innocence at trial. If you have insufficient resources or income to pay a fine or costs, you may request the Court to allow you to discharge all or part of your fine or cost by alternative means such as performing community service. If you are not a citizen of the United States of America, a plea of guilty or no contest for the offense charged may result in deportation, the exclusion from admission to this country, or the denial of naturalization under federal law. You have a right to the possession, or notice, of certain evidence upon your request and the right for a record of said possession or notice to be filed with the Court. **Until the Judgment of the Court is satisfied in full, you are obligated to notify the Court of any change in your address, telephone number, or other contact information.**

**2.) PLEA OF GUILTY TO THE CHARGE**

I acknowledge that I am the Defendant in this case and my true name is as it is alleged in the complaint, unless I have submitted a written name correction. I am mentally competent and I understand the charges against me. I understand the minimum and maximum punishment possible in this case. I hereby ACKNOWLEDGE that I have read the admonishment of rights above and I WAIVE all my legal rights, and enter a plea of NOLO CONTENDERE (No Contest) to all charges. I decline my right to review the evidence in my case, I waive my right of discovery of exculpatory evidence, and I waive my right to legal counsel.

If you are financially unable to pay a fine and/or court cost in full (one payment), there are other options, such as time-payment plans and performing community service hours instead of paying the fine and court costs. In certain situations, in which a person cannot perform community service and that person is financially unable (Indigent) to pay their fine and court cost on a time payment plan the Court will hear sworn testimony and look at evidence concerning your financial situation to help you resolve this matter. In certain severe situations the judge can reduce the fine and court costs or eliminate them completely, depending on the severity of your financial situation. Community service options have been expanded by the Texas Legislature to include: (a) attending work and job skills training; (b) a preparatory class for high school equivalency exam; and (c) service at an educational institution.
