**DECLARING RESULTS OF THE SPECIAL ELECTION  
HELD ON NOVEMBER 4, 2025**

**AN ORDINANCE OF THE CITY OF HORSESHOE BAY, TEXAS DECLARING RESULTS OF THE SPECIAL ELECTION HELD ON NOVEMBER 4, 2025, FOR THE PURPOSE OF REAUTHORIZING OF THE LOCAL SALES AND USE TAX AT THE RATE OF ONE-FOURTH OF ONE PERCENT (0.25%) TO CONTINUE PROVIDING REVENUE FOR MAINTENANCE AND REPAIR OF MUNICIPAL STREETS.**

**WHEREAS,** heretofore the Council of the City of Horseshoe Bay, Texas ordered a special election to be held in the City on the 4th day of November, 2025, for the purpose of reauthorizing the local sales and use tax at the rate of one-fourth of one percent (0.25%) to continue providing revenue for maintenance and repair of municipal streets; and

**WHEREAS,** notice of the election was given as required by law and as provided in the election order; and

**WHEREAS,** the said election was duly and legally held on November 4, 2025, in conformity with the election laws of the State of Texas and applicable provisions of the Texas Local Government Code; and

**WHEREAS,** the results of the election have been certified and returned by the proper judges and clerks of the said election; and

**WHEREAS,** the City Council of the City has considered and canvassed the returns of the election held on November 4, 2025; and

**WHEREAS,** it appears to the said City Council, and the City Council so finds, that the said election was in all respects lawfully held; and

**WHEREAS,** it appears to the said City Council, and the City Council so finds, that the Election Administrators for Burnet County and Llano County have tabulated the results of said election and have certified such tabulations to the City Council, and that such tabulations are correct.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HORSESHOE BAY, TEXAS:**

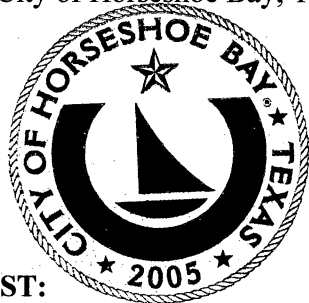
1. That the tabulations of votes cast in the special election held on November 4, 2025, for the purpose of reauthorizing the local sales and use tax at the rate of one-fourth of one percent (0.25%) to continue providing revenue for maintenance and repair of municipal streets, have been made and certified by the presiding Election Administrators for Burnet County and Llano County, a copy of which is attached hereto as **Attachment A**, and made a part hereof, and the same is hereby adopted as the official tabulation of the votes cast at said election; that said tabulation be filed and recorded in the Official Records of the City.
2. That the said official canvass of the returns of said special election reflects the following:

**Proposition A:** The reauthorization of a local sales and use tax in the City of Horseshoe Bay, Texas, at the rate of one-fourth of one percent (0.25%) to continue providing revenue for maintenance and repair of municipal streets. This is a tax increase.

3. That the official canvass of the returns reflects that Proposition A received 750 votes "For" and 629 "Against" and therefore a local sales and use tax at the rate of one-fourth of one percent (0.25%) was authorized.
4. That this Declaration of Results of Election be entered in the minutes of the City Council.

There was 1 Provisional Ballots for the City of Horseshoe Bay Special Election, which was accepted for counting by the Ballot Board.

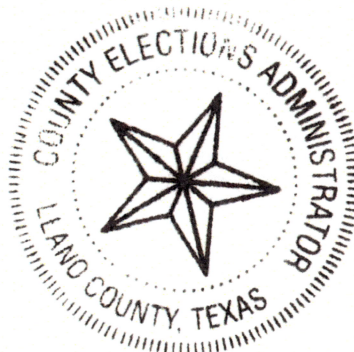

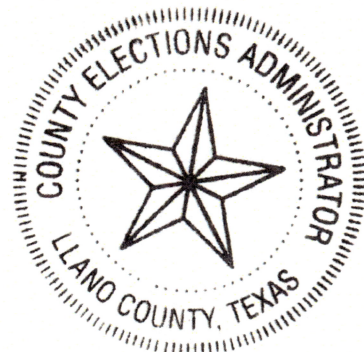

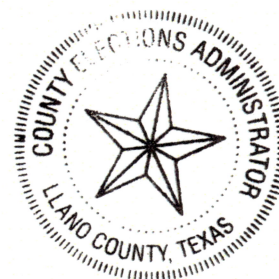
